

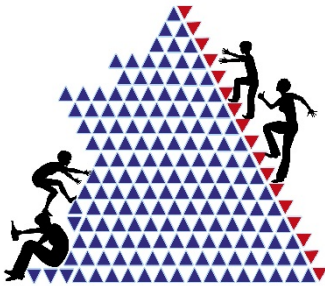

Richard performs school climate audits, including facilitating student and staff focus groups, to assist in promoting equity, intergroup relations and in addressing discriminatory harassment and bullying. Richard was National Co-Chair and contributory author of the acclaimed U.S. Department of Education's publication, "Protecting Students from Harassment and Hate Crimes—A Guide for Schools."
